Thank you for choosing Jimmy's Lawn for your 2018 fertilizing needs. We offer several programs to better suit your individual needs. We ask that you circle the appropriate services, sign and return the completed form as soon as possible. Thank you.

**LAWNS**

- **PROGRAM # 1** \$ \_\_\_\_\_

This program would consist of four applications of a high quality granular fertilizer. No chemicals to control crabgrass, weeds or insects etc. This program would be the least expensive initially but could lead to costly problems down the road from pest damage.

- **PROGRAM # 2** \$ \_\_\_\_\_

This program consists of four applications of the same high-quality fertilizer, mixed with crabgrass and insect control. These chemicals are all registered with the State of CT and are used in very small amounts. This reduces the possible need for much stronger chemicals and re-seeding when a problem occurs. This would also include a modest amount of post emergent weed control.

- **\*\*\*PROGRAM # 3\*\*\*** \$ \_\_\_\_\_

This program consists of five applications, similar to program 2. The fifth application during the year would allow us to use optimum time intervals. Timing is crucial for the chemicals to do the best job controlling pests. During several of the applications, an addition of post-emergent weed control would be applied to help controls weeds in the turf areas.

**SHRUBS**

- **PROGRAM # 4** call for price \$ \_\_\_\_\_

**Protect your investment!** This program would consist of one application of fertilizer to your plants, which will help keep them healthy and resist diseases. The plants would also be sprayed for insect control 2 times during the season and checked for other problems.

**Other services that can be combined with any program at an additional cost are:**

- Tick Control - Call for details, depends on ground covers, woods, etc.
- Deer Control - 2 applications of a non-toxic deer repellent to shrubs. (Repels by taste.)
- Property Sprays to help prevent and control pests.
- Over seeding to help thicken your lawn
- Core aerating
- Spraying of poison ivy when detected.
- Spraying of unsightly weeds growing in drives etc.
- Controlling of fungus when detected.

**(OVER PLEASE)**

- Programs 2 & 3 include Pendimethyln or Dimension for crabgrass and Allectus, which contains both Merit for grub control and Talstar for surface insects. If you have any questions concerning these chemicals, please call.
- The main difference between program 2 & 3 is that we will focus more on post emergent weed control and bentgrass with program 3.
